**Subject:- Issue of Hall Ticket for AITT under CTS (Semester System) to be held in July/August, 2017 - Regarding.**

Sir/Madam,

As you are aware that the AITT under CTS (Semester system) is proposed to be held from **18<sup>th</sup> July, 2017 to 10<sup>th</sup> August, 2017** and the hall tickets has to be distributed to all eligible trainees well in advance before the commencement of AITT.

In this regard, it is informed that the upload of sessional marks, exam fee and attendance of trainees by the concern ITIs is mandatory for eligibility of trainee to get a hall ticket of AITT July, 2017. The NCVT MIS portal is open for this activity.


In this connection, you are requested to complete the above activities well before **30.06.2017**, so that Hall Tickets can be processed on NCVT MIS Portal. The hall tickets will be generated automatically over night by DGT and made available to concern ITI through NCVT MIS portal and ITI can download itself for further distribution to trainees once the eligibility criteria is complete by ITI then hall ticket can be download next day. These activities are scheduled as per details given below:-

In view of above, you are requested to strictly follow up the above dates and also ensure entry of sessional marks, examination fees and attendance by the concerned ITIs under your control, so that hall tickets can be distributed to trainees well in advance before commencement of AITT under CTS from **18.07.2017**. Candidates without NCVT MIS generated Hall Ticket will not be allowed to appear in exam. Ensure that hall ticket is given only to eligible trainees.
