In the CE&T, Memo. 1<sup>st</sup> cited, all the Principals of Govt. and Pvt. ITIs were instructed to remit the Examination Fee collected from the Candidates to the following Head of Account and submit the Challan with details to the District Convener concerned.

In the G.O. 3<sup>rd</sup> cited, Govt. have accorded permission to collect all the revised Examination Fee of AITT by way of Demand Drafts in favour of RDDs (App.) and after remitting the Central share to the DGE&T, New Delhi to utilize the remaining fee to conduct AITT Examination and for declaration of Results.

In terms of G.O. 3<sup>rd</sup> cited, and in partial modification to the CE&T Cir. Memos 1<sup>st</sup> and 2<sup>nd</sup> cited, all the Principals of Govt. and Pvt. ITIs were instructed to remit all the Examination fee collected from the candidates for AITT July'2016 (Semester System) and SCVT May'2016 through Demand Drafts in favour of Regional Deputy Directors concerned and submit the Demand Drafts to the District Conveners /Principal concerned vide CE&T Memo 4<sup>th</sup> cited.

In the reference 5<sup>th</sup> cited, the principal Govt. ITI, Aluru has stated that he has remitted the examination fee through Challans instead of Demand Drafts by mistake and requested to permit the candidates for AITT July'2016 (Semester System). Similar requests also received from some of the RDDs (App.) in the State over phone.
